## **1. ELIGIBILITY**

Candidates with the following qualifications are eligible to seek admission to the Ph.D. programme of university:

### **1.1 Eligibility Criteria for Master's Degree Holders:**

Minimum Academic Qualifications for Admission to the Ph.D. Programme 1-year/ 2-semester master's degree programme after a 4-year/ 8-semester bachelor's degree programme or a 2-year/ 4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time. Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

### **1.2 Eligibility for Ph.D. Admission through M.Phil. Qualification:**

Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

### **3. SELECTION PROCEDURE**

Admission to the Ph.D. programme shall be made using the following methods:

#### **3.1 Admission of Candidates Qualified in National-Level Eligibility Tests**

University may admit students who qualify for fellowship/scholarship in UGC-NET/UGC-CSIR NET/GATE/CEED and similar National level tests based on an interview.

**Abbreviations:** NET = National Eligibility Test, CSIR = Council of Scientific and Industrial Research, GATE = Graduate Aptitude Test in Engineering, CEED = Common Entrance Test for Design

And/or

#### **3.2 Admission Through University-Level Entrance Test**

University may admit students through an Entrance Test conducted by the University. The Entrance Test syllabus shall consist of:

- a) 50% Research Methodology
- b) 50% Subject-Specific Content

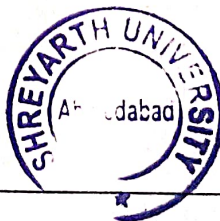
Students who have secured 50% marks in the entrance test are eligible to be called for the interview.

- University may decide the number of eligible students to be called for an interview based on the number of Ph.D. seats available.
- Provided that for the selection of candidates based on the entrance test conducted by the University:
  - a) a weightage of 70% for the entrance test shall be given.
  - b) a weightage of 30% for the performance in the interview/viva-voce shall be given.

The monitoring of admission and selection process on the above line will be carried out by the evaluation committee to be constituted by the provost from time to time.

- Section 2: Research Methodology Descriptive Questions (5 Questions 10 Marks)



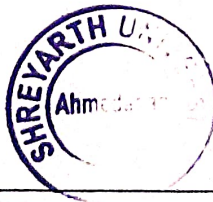

The aspiring candidates, their parents and well-wishers are advised to check the website of university from time to time for all the latest information updates on the admission process.

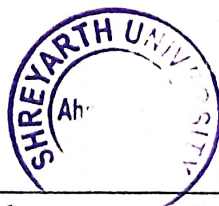

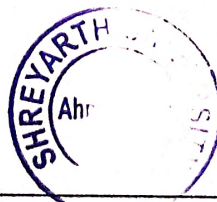
